ORDINANCE NO. 11-10
AN ORDINANCE IMPOSING A BANK FRANCHISE AND LOCAL DEPOSIT TAX: SETTING FORTH TIME TABLES FOR THE COLLECTION OF SUCH TAX FOR THE YEAR 2011 AND ALL SUBSEQUENT YEARS: AND SETTING FORTH ENFORCEMENT PROCEDURES, INCLUDING PENALTIES FOR THE COLLECTION OF DELINQUENT TAXES.
BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SOMERSET, KENTUCKY AS FOLLOWS:
SECTION 1: There is hereby imposed on all "financial institutions" as defined in KRS Chapter 136, located within the corporate limits of the City of Somerset, Kentucky, for the 2011 tax year and all subsequent years, a franchise tax at the rate of 0.025% on all deposits, as defined in KRS Chapter 136, maintained by such financial institutions.
SECTION 2: The City of Somerset, Kentucky will issue tax bills to financial institutions no later than December 1 of each year. Payment of the tax shall be due with a two percent (2%) discount by December 31 of each year, or without discount by January 31 of each year.
SECTION 3: The City of Somerset, Kentucky, shall have a lien for taxes on the property assessed for taxes to the extent allowed under KRS 134-420.
SECTION 4: All taxes due in accordance with these sections which are not paid before June 30, 2012 for the tax year 2011, or which are not paid before January 31, for all subsequent tax years shall be deemed delinquent and shall be subject to a penalty of .20% and shall bear interest at the rate of .6% per annum.
SECTION 5: All moneys collected pursuant to these sections shall be paid into the General Fund of the City to be used for the payment of proper expenditures as determined by the City Council.
SECTION 6: The City Clerk is hereby directed to send a copy of their Ordinance to the Commissioner of the Kentucky Department of Revenue, Frankfort, Kentucky.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SOMERSET, KENTUCKY, AUTHORIZING AND APPROVING THE ISSUANCE OF ITS GENERAL OBLIGATION BONDS, SERIES OF 2011 IN THE APPROXIMATE AMOUNT OF \$8,810,000 (WHICH AMOUNT MAY BE DECREASED BY UP TO \$880,000) FOR THE PURPOSE OF FINANCING CERTAIN PUBLIC PROJECTS AS DESCRIBED BELOW, FOR THE USE AND BENEFIT OF THE CITIZENS OF THE CITY; AUTHORIZING THE LEVY OF A DIRECT ANNUAL TAX ON ALL TAXABLE PROPERTY WITHIN THE CITY, IN ADDITION TO ALL OTHER TAXES, IN AN AMOUNT SUFFICIENT TO PAY THE PRINCIPAL OF AND INTEREST ON THE BONDS WHEN AND AS THE SAME BECOME DUE; AUTHORIZING THE ESTABLISHMENT OF CERTAIN FUNDS TO PROVIDE FOR THE COLLECTION OF THE PROCEEDS OF THE TAX AND THE PAYMENT OF THE BONDS; AUTHORIZING THE PUBLICLY ADVERTISED, COMPETITIVE SALE OF SAID BONDS AND THE DISBURSEMENT OF THE PROCEEDS THEREOF; AUTHORIZING CERTAIN OTHER ACTIONS WITH REGARD TO THE FINANCING AND THE ACQUISITION, CONSTRUCTION, AND EQUIPPING OF THE PROJECTS GENERALLY; AND TAKING OTHER RELATED ACTION.

AN ORDINANCE TO THE CITY OF SOMERSET SETTING THE MAXIMUM SPEED LIMIT ON A CERTAIN CITY STREET KNOWN AS "BARNETT STREET", WHICH IS WITHIN THE CORPORATE LIMITS OF THE CITY OF SOMERSET, PULASKI COUNTY, KENTUCKY AND THEREFORE UNDER THE CITY'S JURISDICTION; WHEREAS, THE COMMON COUNCIL FOR THE CITY OF SOMERSET HAS DETERMINED THAT SAID CITY STREET SHOULD HAVE A LOWER MAXIMUM SPEED LIMIT DURING SCHOOL HOURS IN ORDER TO PROTECT THE SAFETY AND WELL BEING OF THE COMMUNITY AND PARENTS, CHILDREN, AND STAFF OF MEECE MIDDLE SCHOOL AND THE SURROUNDING NEIGHBORHOODS AND SCHOOLS DURING SCHOOL HOURS AS SET FORTH BELOW; NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SOMERSET, PULASKI COUNTY, KENTUCKY, AS FOLLOWS: Section I: That the speed limit on Barnett Street be changed, or enforced effectively if already set be previous Ordinance(s), at a maximum of Twenty-Five (25) miles per hour during school hours which will be set by the Council as "7:30 AM to 3:30 PM, Monday through Friday", and that the Council herein authorizes signage or lights to be placed on said street in order to caution and enforce the speed limit during school said hours. Section II: If any section or provision of this Ordinance is declared invalid by a court of competent jurisdiction for any reason, such declaration shall not invalidate, or adversely affect, the remainder of this Ordinance. Section III: This Ordinance shall be in full force and effect from and after its passage, publication and recording, according to law.
