

ORDINANCE NO. 09- 16

AN ORDINANCE ANNEXING WITH THE CONSENT OF THE LANDOWNER, ALLEN MAYFIELD, A BOUNDARY OF REAL ESTATE KNOWN 169 SLATE BRANCH ROAD, SOMERSET, KY, TO THE CITY OF SOMERSET, KENTUCKY,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SOMERSET, KENTUCKY:

I. That the City of Somerset, Kentucky does hereby annex to the City of Somerset, Kentucky, pursuant to KRS 81A.412, the following boundary of unincorporated territory is adjacent or contiguous to the city's boundaries; and by reason of population density, commercial, industrial, institutional, or governmental use of land, or subdivision of land, the property is urban in character, or suitable for development for urban purposes without unreasonable delay:

A certain tract or parcel of land located and being in Pulaski County, State of Kentucky, and more fully described as follows, to wit: **(See Exhibit "A", attached hereto and incorporated herein in full by reference.)**

II. That the record title holder to said property according to the deed of record recorded in the Pulaski County Clerk's Office, Somerset, KY, Allen Mayfield, has formally requested that said property be annexed as evidenced by the attached "Annexation Request Form" signed by Mr. Mayfield. **(See Exhibit "B", attached hereto and incorporated herein in full by reference.)**


III. That the landowner stated above further waived in writing the 60 day waiting period required for non-consensual annexation as evidenced by the attached "Annexation Request Form" described above.

IV. That the clerk is ordered to adapt the City Map to reflect said annexation and to submit the same to any and all governmental agencies to which submittal is required, included but not limited to, the Commonwealth of Kentucky – Kentucky Land Office.

City of Somerset, KY. Annexation Ordinance No. 09-16
Description

A certain tract or parcel of land located on the south side of KY Hwy. 1642 (Slate Branch Road) to include the lands of Allen Mayfield and a part of the existing road right-of-way of KY Highway 1642, said parcel of land beginning on a point adjacent to the City limits of Somerset, KY. per Ordinance No. 09-12, and more particularly described as follows:

The following description was prepared by Anthony G. Thompson PLS #3630 of AGT Land Surveying, Firm Permit #496, said description was prepared using record information from the Pulaski County Court Clerk's office, in Somerset, Kentucky and right-of-way data from the Kentucky Transportation cabinet, plans for US Highway 27, Kentucky Highway 1642, and the Somerset by-pass. Some field measurements were taken on existing pavement and existing monumentation using GPS, and noted on attached plat. The purpose of this survey is to delineate the limits of the aforesaid annexation. It does not in any way reflect a determination of the individual parcel boundaries and should not be used for this purpose.

Beginning on a point in the KY. Hwy. 1642 (Slate Branch Road) right-of-way northwest of the centerline intersection of KY. Hwy. 1642 and Mayfield Blevins Drive. Said point having a KY State Plane single zone coordinate of (E: 5,248,207.476, N: 3,537,054.418), and also adjoining the south side of the City Limits per Ordinance No. 09-12

Thence with the west right-of-way of Mayfield Blevins Drive and Allen Mayfield (Deed Book 208, page 143 and Deed Book 404, page 200) S 04°23'19" W, 222.39' to a (existing) 1" Square rod;

Thence running with the south line of said Mayfield N 85°27'50" W, 199.74' to a (existing) 1" steel pipe;

Thence with the west line of said Mayfield N 04°35'07" E, 222.88' to a point in the Somerset City Limit Line;

Thence with said Somerset City Limit Line S 85°19'23" E, 198.98' to the **point of Beginning**;

Said Annexed boundary having an area of 44,385 square feet or **1.02 acres**.

All bearings and distances described herein are based on Grid North Kentucky State Plane Single Zone (1600).

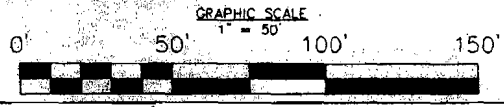
