FIRM JEAN-SCORIALION AGREEMENT

THIS AGREEMENT is made and entered into this 70th day of September, 2005, by and between SOMERSET GAS SERVICE ("Somerset"), a manicipal utility award by the City of Somerset, a manicipality organized worker the lows of Kennicky, and NORTH AMERICAN ENERGY CORPORATION (North American"), a Kentucky Carporation, 333 West Vine Street, Suite 300, Laxington, KY 40307.

WHEREAS, North American has acquired natural gas supplies in southeastern Kentucky from various producers;

WHEREAS, North American desires to enter into an agreement whereby Samerset will transport natural gas procured by North American and delivered to Somerset's natural gas pipeline system (the "Pipeline System") at the Point(s) of Receipt described in Exhibit A to this Agreement to the Point(s) of Delivery described in Exhibit B to this Agreement; and
WHEREAS, Somerset, subject to the terms, conditions, and limitations set forth in this Agreement, is willing to transport natural gas for North American on a firm basis by means of its Pipeline System;
