Second reading was given the following Ordinance:

ORDINANCE NO. 01-27

ORDINANCE AMENDING ORDINANCE NO. 80-13, KNOWN AS THE ZONING ORDINANCE AND ALTERING THE ZONING MAP, BY CHANGING A BOUNDARY OF LAND NOW ZONED R-1 TO R-2.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SOMERSET, KENTUCKY:

That Ordinance No. 80-13, known as the zoning Ordinance, Somerset, Kentucky, be and the same is hereby amended by altering the Zoning Map in the following manner:

- I. By changing the following boundary of land being zoned R-1 to R-2.

A certain tract or parcel of land with all the improvements thereon near the limits of the city of Somerset, Pulaski County, Kentucky, and bounded as follows, to-wit:

BEGINNING at a stake in the center of the Crab Orchard Road 10 feet north of Frazure and Gibson corner; thence a line parallel to and ten feet from old line S 78 E 439 feet to a stake; thence N 7 E 100 feet to a stake; thence N 78 W 439 feet to the center of Crab Orchard Road; thence with the center of road 100 feet to the beginning.

Being the same property conveyed to Ada Baker, also known as Pauline Baker, by deed dated August 19, 1946 from Elliott Cundiff and Anna Louise Cundiff, his wife, as appears of record in Deed Book 150, Page 79, Pulaski County Court Clerk's Office, Kentucky.

Property Known As: 311 Crab Orchard Road, Somerset, Kentucky 42501

- II. The City Clerk of the City of Somerset, Kentucky is hereby authorized to alter the Zoning Map to reflect said change.

- III. This Ordinance shall be in full force and effect from and after adoption.


First Reading: December 10, 2001
