## **MINUTES OF MEETING HELD MARCH 10, 2003**

## ORDINANCE NO. 03-C/

AN ORDINANCE CLOSING A CERTAIN 30' RIGHT-OF-WAY OR STREET RUNNING EAST TO WEST ON THE NORTHEN END OF THE PROPERTY OWNED BY LAKE CUMBERLAND FUNERAL HOME IN THE CITY OF SOMERSET, KENTUCKY.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SOMERSET, KENTUCKY:

Whereas, the City of Somerset, Kentucky, having determined that a 30' right-of-way or street'running east to west on the northern end of the property, plat and description of which is attached hereto, should be closed;

IT IS THEREFORE ORDAINED by the Common Council of the City of Somerset, Kentucky that said 30' right-of-way shall be closed and abandoned and that a more particular description of said portion of said alleyway is attached hereto on the description and plat aforesaid, and marked as Exhibit "A".
