



RESOLUTION

Whereas, the <u>Somerest</u> City Council doesn it necessary to provide for the orderly auccassion of the Office of City Mayor in the event of the absence or disability of the Mayor as dofined in KRS 390, a vacancy of the Office of City Mayor will be filled in accordance with Suction 152 of the Kentucky Constitution; and the line of succession contained in this ORDINANCE is to ensure that a City governmental official is available to serve in the absence of disability of the City Mayor, or any successor,

Now, therefore,

Re it resolved by the <u>Somerset</u> City, Council, Commonwealth of Kentucky, when the shaence of <u>Somerset</u> City Mayor <u>iff Wiles</u>, shall prevent his serving in the office and purforming the responsibilities of the City Mayor they shall be administred temporarily by <u>David Godsey</u> as set forth in KRS 390 and he shall have the powers specified in KRS 390.

If neither the Mayor nor David Godsey are able to serve in the office of Mayor shall be reasoned the office of Mayor by reason of absence of disability or vacancy, then the duties of the Office of Mayor shall be assumed temporarily in succession by a member of The City Council as set forth in KRS 190 and he/she shall have the powers specified in KRS 190.
