

MINUTES OF MEETING HELD JULY 8, 2002

The Common Council of the City of Somerset, Kentucky met in regular session on Monday, July 8, 2002 at 7:00 p.m. with the following present: Mayor JP Wiles, Council Members: Donna Hunley, John Minton, Earl Owens, Pat Bourne, Jerry Burnett, Clarence Floyd, Jerry Wheeldon, Mark Beasley, Robin Daughetee, Charlie New, City Attorney Pro-Tem Dan Yeast and City Clerk David Godsey. Absent: Peggy Dugger, and David Burdine.

Mr. Wheeldon moved the minutes of the last regular meeting held on June 24, 2002 and the reports be approved as delivered. Mr. Beasley seconded the motion. Upon roll call the following Council Members voted "Aye": Mrs. Hunley, Mr. Minton, Mr. Owens, Mr. Bourne, Mr. Burnett, Mr. Floyd, Mr. Wheeldon, Mr. Beasley, Mr. Daughetee, and Mr. New.

Mr. Floyd moved all departmental bills for the month of May be approved. Mr. Burnett seconded the motion. Upon roll call the following Council Members voted "Aye": Mrs. Hunley, Mr. Minton, Mr. Owens, Mr. Bourne, Mr. Burnett, Mrs. Dugger, Mr. Wheeldon, Mr. Beasley, Mr. Daughetee, and Mr. New.

Mr. Ron Toole spoke regarding the College Street Pond located next to his home. He requested that he be permitted to build a gazebo, and landscape the area. Mr. Toole also requested that the pond remain full, unless a storm is approaching, at which time it could be pumped. Mayor Wiles stated that he would like a committee formed to discuss the request, and the request be brought back at a later date.

First reading was given the following Ordinance:

Ordinance Number 02-08

AN ORDINANCE TO PAINT A YELLOW CURB AND ERECT NO PARKING SIGNS AT THE ENTRANCE OF ROCKY HOLLOW.

First reading: July 8, 2002

Mr. Burnett moved to approve the above Ordinance on its first reading. Mr. Daughetee seconded the motion. Upon roll call the following Council Members voted "Aye": Mrs. Hunley, Mr. Minton, Mr. Owens, Mr. Bourne, Mr. Burnett, Mr. Floyd, Mr. Wheeldon, Mr. Beasley, Mr. Daughetee, and Mr. New.

Assistant Chief Skip Norfleet stated that bids for his new vehicle would end on Wednesday July 10, 2002. He inquired if they found a vehicle with the correct specifications between \$21,000. to \$22,000., would they be able to purchase the vehicle with out council approval. Mayor Wiles stated that it would have to be brought before the Fire Committee. The Committee would then have to present to Council for a motion to approve the purchase price of vehicle.

Mr. Wheeldon moved to bring back to the table the Architectural Review Boards Historic Overlay. Mr. Bourne seconded the motion. Upon roll call the following Council Members voted "Aye": Mrs. Hunley, Mr. Minton, Mr. Owens, Mr. Bourne, Mr. Burnett, Mr. Floyd, Mr. Wheeldon, Mr. Beasley, Mr. Daughetee, and Mr. New.

Mr. Bourne moved to approve the Historic Overlay boundaries created by the Architectural Review Board. Mr. Beasley seconded the motion. Upon roll call the following Council Members voted "Aye": Mr. Bourne, Mr. Beasley. Voting "Nay": Mrs. Hunley, Mr. Minton, Mr. Owens, Mr. Burnett, Mr. Floyd, Mr. Wheeldon, Mr. Daughetee, and Mr. New. Motion Defeated.


Mr. Wheeldon moved to advertise for bids for mowing right-of-ways for the gas company. Mr. Beasley seconded the motion. Upon roll call the following Council Members voted "Aye": Mrs. Hunley, Mr. Minton, Mr. Owens, Mr. Bourne, Mr. Burnett, Mr. Floyd, Mr. Wheeldon, Mr. Beasley, Mr. Daughetee, and Mr. New.

Mr. Daughetee moved to request the Mayor send a letter of thanks to members of the Architectural Review Board for their time. Mr. Floyd seconded the motion. Upon roll call the following Council Members voted "Aye": Mrs. Hunley, Mr. Minton, Mr. Owens, Mr. Bourne, Mr. Burnett, Mr. Floyd, Mr. Wheeldon, Mr. Beasley, Mr. Daughetee, and Mr. New.
