SECTION 2: The City Council of the City of Somerset hereby authorizes the Mayor of the City Council of the City of Somerset to execute, accept, or otherwise approve, for and on behalf of the City Council of the City of Somerset all documents, agreements, instruments, or other necessary papers, including, but not limited to, the Project Cooperation Agreement between the Department of the Army and the City Council of the City of Somerset for implementation of the South U.S. 27 Area Sewer Extensions Project as may be considered necessary or required by the Department of the Army for participation of the City Council of the City of Somerset for the implementation of the South U.S. 27 Area Sewer Extensions Project, including, but not limited to, holding and saving the United States government free from all damages arising from the implementation of the South U.S. 27 Area Sewer Extensions Project, except for damages due to the fault or negligence of the Government or its contractors; paying the non-Federal share of total implementation cost; acquisition of lands, easements, and rights-of-way, including those required for relocations, borrow materials, and dredged or excavated material disposal, determined to be necessary for the Project by the Department of the Army; performances or assurance of performance of relocations determined to be necessary for the Project by the Department of the Army; operation and maintenance, repair, replacement, and rehabilitation of the project without cost to the United States of America; and compliance with all applicable Federal and State laws and regulations.
