MINUTES OF MEETING HELD SEPTEMBER 09, 2002

The Common Council of the City of Somerset, Kentucky met in regular session on Monday, September 09, 2002 at 7:00 p.m. with the following present: Mayor JP Wiles, Council Members: Earl Owens, Pat Bourne, Jerry Burnett, Peggy Dugger, David Burdine, Clarence Floyd, Jerry Wheeldon, Mark Beasley, Robin Daughetee, Charlie New, Donna Hunley, and John Minton. Police Chief Larry Godby introduced Ron Swartz as his new Assistant Chief. Chief Godby expressed that based on Swartz ethics, honesty, along with his years of experience, he felt he had made the best choice by promoting Licutenant Ron Swartz to the rank of Major. Major Swartz attended Eastern Kentucky University, and the Department of Criminal Justice's Police Academy. Swartz began his career in law enforcement 1985 at Transylvania University, where he worked with the department of public safety while he attended the police academy. He started as a Patrol Officer with the Somerset Police Department in 1986. In 1989 he became a detective in the Criminal Investigations Division. Then in 1990 he became a Sergeant in the Drug Enforcement Unit. Swartz then helped in developing the Drug Enforcement Unit into the Lake Cumberland Area Drug Task Force. Swartz served as chairman of the board from 1993-1997. In 1993 he was promoted to Lieutenant of the Narcotics Division. In 1994 he became a lieutenant in the Patrol Division. Then in 1999 he was promoted to Senior Lieutenant in the Patrol Division.

the 21st Century (AIR-21), P.L. 106-181, under the Small Community Air Service

Development Pilot Program, 49 U.S.C.§41743 as Airport Feasibility Study Project; and,

WHEREAS, implementation of this project will require the City to enter into various agreements with parties involved;

NOW, THEREFORE, be it resolved by the City of Somerset as follows:

- 1. That the Mayor and City Clerk of the City of Somerset are hereby authorized to execute any and all documents necessary to carry out this project. This authorization shall include but not necessarily be limited to a contract with R.A. Wiedemann & Associates, Inc. and a grant agreement with the U.S. Department of Transportation.
- 2. This Resolution shall take effect upon its passage.
