ORDINANCE NO. 09-01

AN ORDINANCE TO THE CITY OF SOMERSET REGULATING THE USE OF CERTAIN VEHICLES, BOTH MOTORIZED AND SELF-PROPELLED, WITHIN THE CORPORATE LIMITS OF THE CITY OF SOMERSET, PULASKI COUNTY, KENTUCKY; AND REPEALING IN FULL DIVISION I, SECTION 10 OF CITY ORDINANCE NUMBER 70;
