

MINUTES OF MEETING HELD JUNE 9, 2008

The Common Council of the City of Somerset, Kentucky met in a regular session on Monday June 9, 2008 at 7:00 p.m. with the following present: Mayor Eddie Girdler. Mr. Burnett moved to approve the minutes of the last regular meeting held on May 12, 2008, along with the reports to be approved as delivered. Mr. T. Rutherford seconded the motion. Upon roll call the following Council Members voted "Aye": Mr. Childers, Mrs. Hunley, Mr. Minton, Mr. Mitchell, Mr. Burnett, Mr. T. Rutherford, Mrs. Stringer, Mr. Eastham, and Mr. Girdler.

First reading was given the following Ordinance # 08-09:

ORDINANCE NO. 08-09

AN ORDINANCE AMENDING ORDINANCE NO 00-18, KNOWN AS THE ZONING ORDINANCE AND ALTERING THE ZONING MAP, BY CHANGING A BOUNDARY OF LAND NOW ZONED R-2 TO B-2. BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SOMERSET, KENTUCKY.

Mr. Burnett moved to approve the above ordinance # 08-09 on its first reading regarding rezoning property on the corner of W. Columbia and Ohio Streets. Mr. Mitchell seconded the motion. Upon roll call the following Council Members voted "Aye": Mr. Childers, Mrs. Hunley, Mr. Minton, Mr. Mitchell, Mr. Burnett, Mr. T. Rutherford, Mrs. Stringer, Mr. Eastham, and Mr. Girdler.

AN ORDINANCE AMENDING ORDINANCE NO 00-18, KNOWN AS THE ZONING ORDINANCE AND ALTERING THE ZONING MAP, BY CHANGING A BOUNDARY OF LAND NOW ZONED R-2 TO B-2. BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SOMERSET, KENTUCKY.

AN ORDINANCE ADOPTING THE CITY OF SOMERSET, KENTUCKY ANNUAL BUDGET AND PAY AND CLASSIFICATION PLAN FOR THE FISCAL YEAR BEGINNING JULY 1, 2008 AND ENDING JUNE 30, 2009 ESTIMATING REVENUES AND RESOURCES AND APPROPRIATING FUNDS OF THE CITY OF SOMERSET, KENTUCKY.

Mrs. Hunley moved to approve the above ordinance # 08-08 on its first reading regarding adopting the annual budget and pay and classification plan for the fiscal year July 1, 2008 and ending June 30, 2009. First reading was given the following Ordinance # 08-11:

ORDINANCE NO. 08-11

AN ORDINANCE TO THE CITY OF SOMERSET, KENTUCKY, REPEALING IN FULL ORDINANCE NUMBER 288 AND ORDINANCE NUMBER 652, AND ANY AND ALL OTHER ORDINANCES ADDRESSING DOGS AND OTHER ANIMALS IN THE CITY LIMITS, AND ANY AND ALL AMENDMENTS ENACTED REGARDING SAID ORDINANCES; SETTING FORTH THE NEW RULES AND REGULATIONS REGARDING ANIMALS WITHIN THE CORPORATE BOUNDARIES OF THE CITY OF SOMERSET PURSUANT AND IN CONJUNCTION WITH KENTUCKY STATE LAW, SPECIFICALLY: *AGRICULTURE AND ANIMALS*, KRS CH. 246 ET SEQ.; *DOGS*, KRS. CH. 258; AND *STRAYS AND ANIMALS RUNNING AT LARGE*, KRS CH. 259;


Whereas, the City of Somerset is located in Pulaski County, Kentucky;
