"Act"), for the payment of which the full faith, credit and taxing power of the City will be
pledged pursuant to a Bond Ordinance to be considered at a later date.
NOW THEREFORE, BE IT RESOLVED BY THE CITY OF SOMERSET,
KENTUCKY, AS FOLLOWS:
Section 1. Designation of Bond Counsel and Financial Advisor. The law firm of
Wyatt, Tarrant & Combs, LLP is designated as Bond Counsel in connection with the Bonds as contemplated by the engagement letter attached hereto. The firm of Ross, Sinclaire &
Associates, LLC is designated as Fiscal Agent in connection with the Bonds as contemplated by
the proposed Contract of Agreement attached hereto.
Section 2. Conflicts. All resolutions, orders or parts thereof in conflict with the
provisions of this Resolution are, to the extent of such conflict, hereby repealed and the provisions of this Resolution shall prevail and be given effect.

Section 3. Effective Date. This Resolution shall take effect from and after its
passage, as provided by law.
