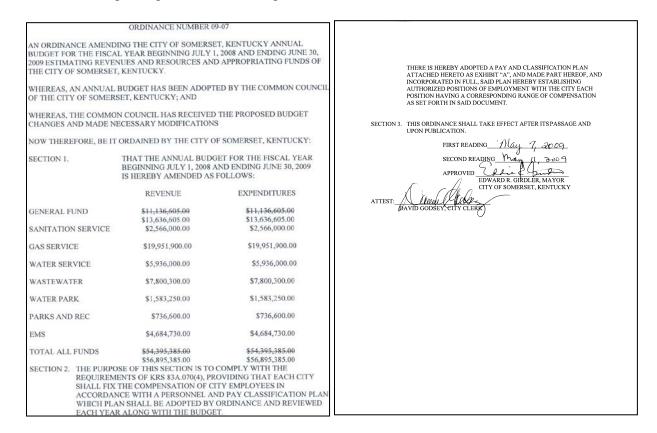
## **MINUTES OF MEETING HELD MAY 11, 2009**

The Common Council of the City of Somerset, Kentucky met in a regular session on Monday, May 11, 2009, at 7:00 p.m. with the following present: Mayor Eddie Girdler. Council Members: Jerry Girdler, Mike New, Donna Hunley, John Minton, Jim Mitchell, Pat Bourne, Jerry Burnett, Tim Rutherford, Jim Rutherford, Linda Stringer, Jerry Wheeldon, and Steve Kelley. City Attorney Carrie Wiese and City Clerk David Godsey.

Mr. Wheeldon moved to approve the minutes of the last regular meeting held on April 27, 2009, along with the reports to be approved as mailed. Mr. Mitchell seconded the motion.
