
## MINUTES OF MEETING HELD FEBRUARY 10, 2020


Mr. Girdler made a motion to approve the following Resolution Number 20-02: Purchase of Lots 1, 3, 4, 5 and Thirty (30) Foot Road of a Plat Named "Oscar Hornsby Project" for Three Hundred and Sixty Thousand Dollars (\$360,000). Mr. T. Eastham seconded the motion. Upon roll call the following Council Members voted "Aye": Mr. Minton, Mr. Mitchell, Mr. Godsey, Mr. T. Eastham, Mr. Burdine, Mr. Dalton, Mr. J. 
Mr. Burdine made a motion to approve the following Resolution Number 20-03: Purchase of South Vine Street (061-4-8-50.1), 250 South Vine Street (061-4-8-50), and 300 Town Springs

(061-4-8-50.2) known as "Cundiff Square" for One Million Dollars (\$1,000,000). Mr. Dalton seconded the motion. Upon roll call the following Council Members voted "Aye": Mr. Minton, Mr. Godsey, Mr. T. Eastham, Mr. Burdine, Mr. Dalton, Mr. J. Eastham, Mr. Girdler, and Mrs. Hunley. "No" Mr. Mitchell. Motion passed.

First reading was given the following Ordinance Number 20-03: An Ordinance Amending Ordinance No. 00-18, Known as the City's Zoning Ordinance, and Altering the Zoning Map to Reflect said Amendment, Based on the Findings of Fact made by the Planning and Zoning Board, and Based on Said Board's Recommendation of a Zone Change (129 Circle Street Parcel # 061-5-3-84 from R-2 to R-3).
