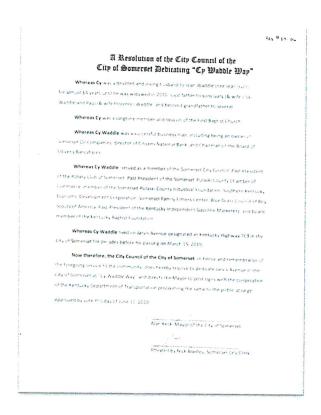
MINUTES OF MEETING HELD JUNE 10, 2019

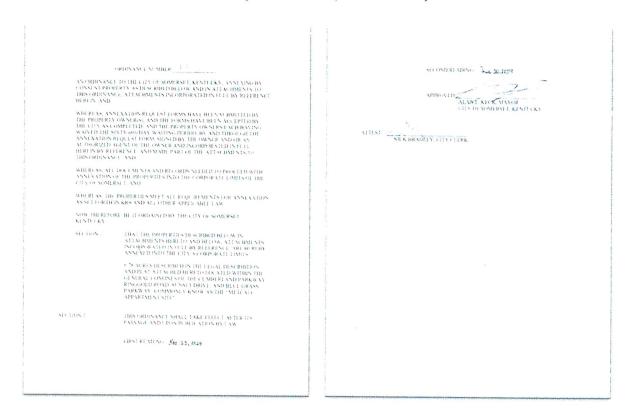

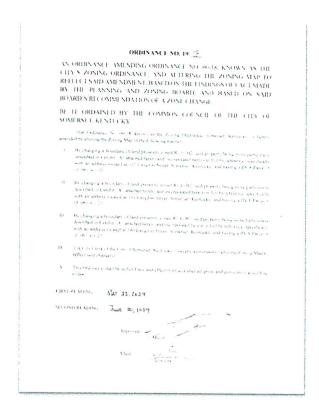
