

MINUTES OF MEETING HELD FEBRUARY 27, 2017

The Common Council of the City of Somerset, Kentucky met in a regular meeting on Monday February 27, 2017, at 7:00 p.m. with the following present: Mayor Eddie Girdler. Council Members; Brian Dalton, Jerry Wheeldon, Jimmy Eastham, Jerry Girdler, Donna Hunley, John Minton, Jim Mitchell, John Adams, Amanda Bullock, and David Burdine. City Attorney Carrie Weise, and City Clerk Nick Bradley. Absent: Council Members Mike New and Tom Eastham.

Mr. Wheeldon moved to approve the minutes of the regular meeting held on February 13, 2017 along with reports as mailed. Mr. Dalton seconded the motion. Second reading was given the following Ordinance No. 17-02:

ORDINANCE NUMBER 17-02

AN ORDINANCE AMENDING/REPLACING IN FULL THE CITY OF SOMERSET, KENTUCKY'S CURRENT PAY & CLASSIFICATION PLAN AS SET FORTH IN ORDINANCE ~~15-11~~, WHICH SHALL REMAIN IN EFFECT UNTIL SUCH TIME AS THE PLAN IS AMENDED/ALTERED BY PROPER ACTION OF THE COMMON COUNCIL;

WHEREAS, KRS 83A.070(4) REQUIRES THAT EACH CITY SHALL FIX THE COMPENSATION OF CITY EMPLOYEES IN ACCORDANCE WITH A PERSONNEL AND PAY CLASSIFICATION PLAN, WHICH PLAN SHALL BE ADOPTED BY ORDINANCE, AND REVIEWED/AMENDED AS NECESSARY BY THE CITY COUNCIL; AND

WHEREAS, COUNCIL WISHES TO AMEND THE CURRENT PAY AND CLASS PLAN AS PRESENTED AND SET FORTH IN "EXHIBIT A", ATTACHED HERETO AND INCORPORATED IN FULL IN THIS ORDINANCE BY REFERENCE;

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SOMERSET, KENTUCKY:


SECTION 1. THERE IS HEREBY ADOPTED AN UPDATED PAY AND CLASSIFICATION PLAN, ATTACHED HERETO AND INCORPORATED IN FULL BY REFERENCE.


SECTION 2. THE CHANGES/AMENDMENTS MADE TO THE PAY AND CLASSIFICATION PLAN SHALL REPLACE THE FORMER PAY AND CLASSIFICATION PLAN IN FULL.

SECTION 3. THIS ORDINANCE SHALL TAKE EFFECT UPON ITS PASSAGE AND UPON PUBLICATION ACCORDING TO LAW.

AN ORDINANCE AMENDING THE CITY OF SOMERSET, KENTUCKY ANNUAL BUDGET FOR THE FISCAL YEAR BEGINNING JULY 1, 2016 AND ENDING JUNE 30, 2017 ESTIMATING REVENUES AND RESOURCES AND APPROPRIATING FUNDS OF THE CITY OF SOMERSET, KENTUCKY.

WHEREAS, AN ANNUAL BUDGET HAS BEEN ADOPTED BY THE COMMON COUNCIL OF THE CITY OF SOMERSET, KENTUCKY; AND

WHEREAS, THE COMMON COUNCIL HAS RECEIVED PROPOSED BUDGET CHANGES AND HAS MADE NECESSARY MODIFICATIONS;

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SOMERSET, KENTUCKY:

SECTION 1.


