

MINUTES OF MEETING HELD NOVEMBER 23, 2015

The Common Council of the City of Somerset, Kentucky met in a regular meeting on Monday November 23, 2015, at 7:00 p.m. with the following present: Mayor Eddie Girdler. Council Members; Jerry Burnett, Tom Eastham, David Burdine, Linda Stringer, Jerry Wheeldon, Jimmy Eastham, Jerry Girdler, Mike New, and Pat Bourne. City Attorney Carrie Weise. Mr. T. Eastham moved to approve the minutes of the regular meeting held on November 9, 2015 along with reports as mailed. Mr. New seconded the motion. Upon roll call the following Council Members voted "Aye": Mr. Burnett, Mr. T. Eastham, Mr. Burdine, Ms. Stringer, Mr. Wheeldon, Mr. J. Eastham, Mr. Girdler, Mr. New, and Mr. Bourne.

Northern Middle School Girls Basketball Team State Champions were in attendance. Mr. Wheeldon moved for Resolution 15-07 be given in support of the 35/3 winning season. Mr. Burnett turned in a petition signed by the residents of Crane Street requesting it be turned into a one-way street. Mayor referred request to a committee and asked for a report be brought back to council at next meeting.

First reading was given the following Ordinance No. 15-14:

ORDINANCE NO. 15-14

AN ORDINANCE AMENDING ORDINANCE NO. 00-18 KNOWN AS THE CITY'S ZONING ORDINANCE, AND ALTERING THE ZONING MAP TO REFLECT SAID AMENDMENTS, BASED ON THE FINDINGS OF FACT MADE BY THE PLANNING AND ZONING BOARD, AND BASED ON SAID BOARD'S RECOMMENDATION OF ZONE CHANGES FROM R-2 TO R-3 FOR PROPERTY ON OR OFF MONTICELLO STREET; 061-5-4-24, 061-5-4-25, 061-5-4-26, 061-5-4-27, 061-5-4-28.

Mr. Burnett moved to approve the following tax exemption as requested by the Property Value Administrator's Office. 2015 homestead exemption tax refunds to Roger Sadler in the amount of \$47.97. Mr. Wheeldon seconded the motion. Upon roll call the following Council Members voted "Aye": Mr. Burnett, Mr. T. Eastham, Mr. Burdine, Ms. Stringer, Mr. Wheeldon, Mr. J. Eastham, Mr. Girdler, Mr. New, and Mr. Bourne.
