Instructions

- 1. Calculate total <u>Gross Receipts for sale of Alcoholic Beverages</u> of each license issued by the ABC Administrator. Enter amount on (Line 1).
- 2. <u>Regulatory Fee</u>: Calculate 4% of amount entered on (Line 1); enter on (Line 2).
- 3. <u>Yearly License Fee Credit</u>: License Fee will be deducted from regulatory fee until all credit is taken, enter amount (Line 3)
- 4. Enter amount of calculation of <u>Regulatory Fee</u> (Line 2) less Credit (Line 3) on (Line 4).
- 5. <u>Penalty for Late Payment</u>: Failure to file a return and pay monthly remittance by the due date is to be calculated at five percent (5%) of the regulatory fee due (Line 4) for each ninety (90) days or fraction thereof. The total late filing penalty shall not exceed twenty-five percent (25%) of the regulatory fee due (Line 4); provided however, that in no case shall the penalty be less than 10 dollars (\$10.00). Enter amount on (Line 5).
- 6. <u>Interest for Late Payment:</u> Calculate Interest at the rate of eight percent (8%) per annum. This will apply to any late payments of regulatory fee due (Line 4). Enter amount on (Line 6).
- 7. <u>Total Regulatory Fee Due:</u> Calculate Subtotal Regulatory Fee Due (Line 4), Penalty for Late Payment (Line 5), and Interest for Late Payment (Line 6) and enter amount on (Line 7).
