- 1. Calculate total <u>Gross Receipts for sale of Package Distilled Spirits/Wines.</u> Enter amount on (Line 1).
- 2. Calculate total <u>Gross Receipts for sale of Package Malt Beverages.</u> Enter amount on (Line 2).
- 3. <u>Regulatory Fee</u>: Calculate 5% of amount entered for Package Sales of Distilled Spirits and Wine on (Line 1), enter result on (Line 3).

4. <u>Regulatory Fee</u>: Calculate 4% of amount entered for Package Malt Beverage Sales on (Line 2), enter result on (Line 4).

5. <u>Monthly License Fee Credit:</u> License fee will be deducted from regulatory fee until all credit is taken, enter amount (Line 5)

6. Enter amount of calculation of <u>RegulatoryFee(s)</u> (Line 3 + 4) less Monthly Credit (Line 5) on (Line 6).

- 7. <u>Penalty for Late Payment</u>: Failure to file a return and pay monthly remittance by the due date is to be calculated at five percent (5%) of the regulatory fee(s) due (Line 6) for each ninety (90) days or fraction thereof. The total late filing penalty shall not exceed twenty-five percent (25%) of the regulatory fee due (Line 6); provided however, that in no case shall the penalty be less than 10 dollars (\$10.00). Enter amount on (Line 7).
- 8. <u>Interest for Late Payment:</u> Calculate Interest at the rate of eight percent (8%) per annum. This will apply to any late payments of regulatory fee due (Line 6). Enter amount on (Line 8).
- <u>Total Regulatory Fee Due:</u> Calculate Subtotal Regulatory Fee Due (Line 6), Penalty for Late Payment (Line 7), and Interest for Late Payment (Line 8) and enter amount on (Line 9).
