**Stormwater Fee Schedule**

Site Plan application and review: \$285

Residential Developments:

- 1 to 4 lots \$350
- 5 to 25 lots \$500
- 26 to 75 lots \$1,000
- 76 to 150 lots \$1,500
- 150 or more lots \$2,500

Commercial Developments:

- Up to 5.0 acres \$500
- 5.1 to 10.0 acres \$1,200
- 10.1 to 25.0 acres \$2,000
- 25.1 or more acres \$2,500

**Note: These fees do NOT include the permit application fee or permit fees.**

**OPERATION/MAINTENANCE PLAN**

An operation and maintenance plan for the post-development stormwater controls have been developed. The plan includes ownership of the stormwater Best Management Practices (BMP's), parties responsible for operation and maintenance, schedule for inspection and maintenance, routine and long-term maintenance responsibilities, and provision for appropriate access and maintenance easements extending from a public right-of-way to the stormwater controls.
