

ORDINANCE NO. 08-12

AN ORDINANCE TO THE CITY OF SOMERSET, KENTUCKY, CLOSING A PORTION OF BOURNE AVE. LOCATED WITHIN THE CITY'S CORPORATE LIMITS,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SOMERSET, KENTUCKY:

- I. That a portion of Bourne Avenue located within the City of Somerset, specifically beginning at the intersection of Murphy Ave., running East to West, ending at the intersection of Bourne and High Street, said public way running alongside the South facing portion of High Street Baptist Church, should and shall be closed by the City of Somerset.
- II. That all property owners in or abutting the public way, or portion thereof, have been identified, and that said property owners have been given written notice of the proposed closing.
- III. That all property owners in or abutting the public way or portion thereof being closed have given their written, notarized consent to the closing, and copies of the consent shall be attached hereto as Exhibit "A".
- IV. That all ordinances or parts thereof in conflict herewith are hereby repealed and the Clerk is hereby granted authority to make necessary changes to the city street system so that the official map shall reflect the changes set forth herein.
- V. This ordinance closing the above stated street shall be in full force and effect upon passage, approval, and publication according to law.
