## ORDINANCE NO. 09-01

## AN ORDINANCE TO THE CITY OF SOMERSET REGULATING THE USE OF CERTAIN VEHICLES, BOTH MOTORIZED AND SELF-PROPELLED, WITHIN THE CORPORATE LIMITS OF THE CITY OF SOMERSET, PULASKI COUNTY, KENTUCKY; AND REPEALING IN FULL DIVISION I, SECTION 10 OF CITY ORDINANCE NUMBER 70;

WHEREAS, the City of Somerset has determined that the use of certain items such as bicycles, skateboards, roller blades, skates, four wheelers, and dirt bikes within the City of Somerset should be regulated, as such activities can be a safety hazard for those using such items in an improper manner and/or on public or private roadways, as well as for persons operating a motor vehicle when such items are being used on or in close proximity to roadways; and further, said activities can interfere with property owners' rights to quiet enjoyment and protection from damage of their property, as well as the right to protection of public property;

## NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SOMERSET, PULASKI COUNTY, KENTUCKY AS FOLLOWS:

**Section 1:** No person shall, at any time, use, operate or ride upon skateboards on any roadway, sidewalk, or parking lot within the City of Somerset's "No-Skate Zone". The No-Skate Zone shall include the following areas (*please see attached map*, incorporated in full and made part herein by reference, for specific locations of the no-skate zone in each of these areas):

Mt. Vernon Street, Columbia Street, Market Street, Oak Street, Vine Street, Main Street, Maple Street, Central Avenue, College Street, Plum Street, Church Street, Spring Street, Elm Street, Rosewood Street, and Freshman Alley.

Section 2: No person shall, at any time, use, operate or ride upon four wheelers, ATV's, or motorized dirt bikes on **public** property or on a roadway within the City's corporate limits.

Section 3: No person shall, at any time, use any bench, table, garbage can or any other property belonging to the City of Somerset, or belonging to a private organization or individual, as a ramp/jump for any of the above named items in Section 1 or 2, or any other self propelled vehicle including, but not limited to, bicycles, roller blades, or skates, at any location within the City's corporate limits.

Section 4: No person shall use, operate, or ride upon skateboards, four wheelers, ATV's, or motorized dirt bikes on **private** property within the corporate limits of the City of Somerset *unless* the person has obtained consent of the owner of the private property. A person who is the owner of private property in the corporate limits of the City of Somerset, whose spouse, dependent children, or tenants and their dependent children who reside upon the property, shall not be required to have consent to operate the above named items on the private property.

## PUBLICATION SUMMARY OF ORDINANCE 09-01 REGULATING THE USE OF CERTAIN ITEMS; AND REPEALING IN FULL DIV. I, SEC. 10 OF ORDINANCE NO. 70; BE IT ORDAINED BY THE CITY COUNCIL AS FOLLOWS:

Section 1: No person shall, at any time, use, operate or ride upon skateboards on any roadway, sidewalk, or parking lot within the City's "No-Skate Zone" as designated on the map available in the Clerk's office, and incorporated in full herein by reference. The streets affected include: Mt. Vernon St., Columbia St., Market St., Oak St., Vine St., Main St., Maple St., Central Ave., College St., Plum St., Church St., Spring St., Elm St., Rosewood St., Grande Ave. and Freshman Alley.

Section 2: No person shall, at any time, use, operate or ride upon four wheelers, ATV's, or motorized dirt bikes on public property or on a roadway within City limits.

Section 3: No person shall, at any time, use any bench, table, garbage can or any other property, for use with any of the above named items, or any other self propelled vehicle including, but not limited to, bicycles, roller blades, or skates, within the City's limits.

Section 4: No person shall use, operate, or ride upon skateboards, four wheelers, ATV's, or motorized dirt bikes on private property within the City limits *unless* consent is obtained from the owner of the property. The owner of the property, their spouse, their dependent children, their or tenants and dependent children who reside upon the property, shall not be required to have consent.

**Section 5:** Any person violating this Ordinance shall be given a verbal warning for a first offense. Second and subsequent offenses shall be subject to confiscation of the item. Items will be placed in the city police property room or other suitable area for 10 days for all first offenses, and 30 days for all subsequent offenses. The item(s) shall be returned to the violator, or to the parent/guardian if the violator is a minor, after the confiscation period has ended.

Section 6: Any person violating this Ordinance who causes damage(s) to private or public property, shall be financially responsible for all damages caused. If the person violating the Ordinance is a minor, the person's parent/guardian shall be responsible for said damages.

Section 7: This Ordinance shall not apply to motorcycles, motorized scooters, or golf carts that are properly registered under KRS. This Ordinance shall not apply to motorized wheelchairs or scooters intended for persons with disabilities or the elderly. Motorcycles, motorized scooters, or golf carts which are not registered may still be used by authorized individuals, if needed for a special event to ensure efficiency and safety. This Ordinance shall not apply to emergency personnel, or their designees.

Section 8: If any portion of this Ordinance is declared invalid, such declaration shall not invalidate, or adversely affect, the remainder.

Section 9: This Ordinance repeals in full Div. I, Sec.10 of Ordinance No.70.Section 10: This Ordinance shall be in full forward effect from and after its passage, publication and recording.

**Section 5:** Any person violating this Ordinance shall be given a verbal warning for a first offense. Second and subsequent offenses of this Ordinance shall be subject to confiscation of the item used in the violation of this Ordnance. Items confiscated will be placed in the city police property room or other suitable area for 10 days for all first offenses, and 30 days for all subsequent offenses. The item(s) shall be returned to the violator, or to the parent/guardian if the violator is a minor, after the said confiscation period has ended.

**Section 6:** Any person violating this Ordinance who causes damage(s) to private property, or to public property, shall be financially responsible for all damages caused as a result of the violation. If the person violating the Ordinance is a minor, the person's parent/guardian shall be responsible for said damages per KRS.

**Section 7:** This Ordinance shall not be applicable to motorcycles, motorized scooters, or golf carts so long as such items are properly registered under any applicable requirements of KRS. This Ordinance shall further not apply to motorized wheelchairs or scooters intended for persons with disabilities or the elderly. Motorcycles, motorized scooters, or golf carts which are not registered may still be used by special event staff or volunteers, or other authorized individuals, if needed to help organize, monitor, or operate an event efficiently and safely. This Ordinance shall not be applicable to any items used by emergency personnel such as the City's Police Department or Fire and EMS Departments, or their designees.

**Section 8:** Any section or provision of this Ordinance which is declared invalid by a court of competent jurisdiction for any reason, such declaration shall not invalidate, or adversely affect, the remainder of this Ordinance.

**Section 9:** This Ordinance repeals in full Division I, Section 10 of City Ordinance Number 70, which appears as follows in said Ordinance:

Section 10. - Use of coasters, roller skates, and similar devices restricted. - No person upon roller skates, or riding in or by any means of any coaster, toy vehicle, or similar device, shall go upon any roadway except while crossing a street on a crosswalk and when so crossing such person shall be granted all the rights and shall be subject to all of the duties applicable to pedestrians.

**Section 10:** This Ordinance shall be in full force and effect from and after its passage, publication and recording, according to law.
