## ORDINANCE NO. 10-03

AN ORDINANCE TO THE CITY OF SOMERSET, KENTUCKY, AMENDING ORDINANCE NO. 01-15, WHICH ESTABLISHES RATES AND CHARGES FOR USE OF THE SERVICES AND FACILITIES OF THE MUNICIPAL WATER COMPANY AND ESTABLISHING CHARGES FOR CONNECTION THERETO, ADOPTED BY THE COMMON COUNCIL ON JUNE 11, 2001;

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SOMERSET, KENTUCKY:

- (I) That amendments are hereby made to Ordinance No. 01-15 as set forth below:
  - Section 3(B) shall now read as follows:
    - B. Connect Fees: (Non-refundable)

a) Residential

\$15.00

(If customer is in good standing as defined herein.)\*

\$30.00

(If customer is not in good standing as defined herein.)\*

\* For purposes of this Ordinance, a customer in "Good Standing" shall mean a current customer, or a customer who has had a utility account within a just prior 30 day period, that has no delinquent accounts for which the City of Somerset Utilities Department bills (including but not limited to: Gas, Water, Sewer, and Garbage). Delinquent accounts shall be those that have past-due, outstanding obligations as of the date of request for any utility reconnection.

b) Commercial

\$15.00-\$100.00

(Depending on size of meter)

c) Residential Reconnect after Failure to Pay

If a reconnect is requested because utility service was disconnected due to failure to provide payments as required by the current Utility Department policies and all other applicable policies or law, the fee shall be \$60.00 to reconnect.

- Section 3(C) shall now read as follows:

C. Returned Checks:

\$25.00

- (II) If any part of this ordinance amending Ordinance 01-15, or the Amendments herein made, is deemed by a court of competent jurisdiction to be unenforceable or unconstitutional, the remaining provisions of this ordinance shall continue in full force and effect.
- (IV) This ordinance shall be in full force and effect upon passage, approval, and publication according to law.

AN ORDINANCE TO THE CITY OF SOMERSET, KENTUCKY, AMENDING ORDINANCE NO. 99-13 ESTABLISHING RATES AND CHARGES FOR USE OF THE SERVICES AND FACILITIES OF THE MUNICIPAL WATER COMPANY AND ESTABLISHING CHARGES FOR CONNECTION THERETO.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SOMERSET, KENTUCKY:

- I. The basic water rates shall be as follows:
  - A. Residents of the City of Somerset (excluding those serviced by a water district):

B. Non-Residents of the City of Somerset (excluding water districts):

E. Line Extensions

Contractor or builder will pay for total cost of extension. Plans must be approved by Kentucky Division of Water. No refunds for connections. Somerset Water Service takes over and maintains lines. Contractor must be approved by Somerset Water Service. Somerset Water Service.

4. Leak Adjustments

Somerset Water Service will adjust one bill per year for an underground customer leak. The adjustment will be calculated on the highest monthly bill received. The amount credited will be one-half the difference between the highest bill and the customers average bill.

- 5. Any ordinance in conflict herewith is hereby repealed.
- 6. This Ordinance shall be in full force and effect upon passage, approval and publication according to law.
