Mr. Wheeldon moved to approve the minutes of the regular meeting held on August 12, 2019 along with reports as mailed. Mr. Mitchell seconded the motion. Mr. Mitchell made a motion to approve the following Ordinance Number 19-20: Fixing the Tax Levy, Ad Valorem, Franchise Tax, and Tax for the City of Somerset, Kentucky, for the Fiscal Year Beginning July 1, 2019 and Ending June 30, 2020 Providing Penalty and Interest for Non-payment. ORDINANCE NO. 19-22

AN ORDINANCE AMENDING ORDINANCE NO. 00-18, KNOWN AS THE CITY'S ZONING ORDINANCE, AND ALTERING THE ZONING MAP TO REFLECT SAID AMENDMENT, BASED ON THE FINDINGS OF FACT MADE BY THE PLANNING AND ZONING BOARD, AND BASED ON SAID BOARD'S RECOMMENDATION OF A ZONE CHANGE.


BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SOMERSET, KENTUCKY:


The Ordinance No. 00-18 known as the Zoning Ordinance, Somerset, Kentucky, is hereby amended by altering the Zoning Map as follows:

- By changing a boundary of land presently zoned R-1 to R-1, said property being more or less bounded on the north by ... attached hereto and incorporated herein as full by reference, located west of ... north of Highway 40 and east of ... Somerset, Kentucky, and being part of PVA Parcel 00-1-1-008.
- That by a link of the City of Somerset, Kentucky is hereby authorized to alter the Zoning Map to reflect said change.
- That Ordinance shall be in full force and effect from and after adoption and publication according to law.


