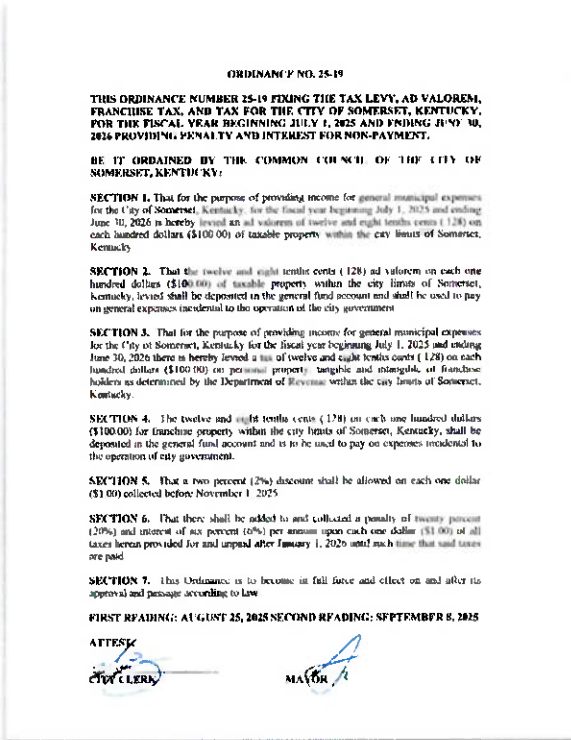
Mr. Dalton made a motion to approve the minutes of the meeting of August 25, 2025. Ms. Bullock seconded the motion. Upon roll call the following Council Members voted "Aye": Mr. Wheeldon, Ms. Dick, Ms. Lawson, Mr. Hunley, Mr. Minton, Mr. Godsey, Ms. Bullock and Mr. Dalton.

Ms. Lawson made a motion to approve the following Ordinance Number 25-18: IMPOSING A BANK FRANCHISE AND LOCAL DEPOSIT TAX: SETTING FORTH TIME TABLES FOR THE COLLECTION OF SUCH TAX FOR THE YEAR 2025 AND ALL SUBSEQUENT YEARS: AND SETTING FORTH ENFORCEMENT PROCEDURES, INCLUDING PENALTIES FOR THE COLLECTION OF DELINQUENT TAXES. Ms. Bullock seconded the motion. Upon roll call the following Council Members voted "Aye": Mr. Wheeldon, Ms. Dick, Ms. Lawson, Mr. Hunley, Mr. Minton, Mr. Godsey, Ms. Bullock and Mr. Dalton.



Mr. Wheeldon made a motion to approve the following Ordinance Number 25-19: FIXING THE TAX LEVY, AD VALOREM, FRANCHISE TAX, AND TAX FOR THE CITY OF SOMERSET, KENTUCKY, FOR THE FISCAL YEAR BEGINNING JULY 1, 2025 AND

ENDING JUNE 30, 2026 PROVIDING PENALTY AND INTEREST FOR NON-PAYMENT. Mr. Hunley seconded the motion. Upon roll call the following Council Members voted "Aye": Mr. Wheeldon, Ms. Dick, Ms. Lawson, Mr. Hunley, Mr. Minton, Mr. Godsey, Ms. Bullock and Mr. Dalton.



Mr. Dalton made a motion to approve a tax refund for Homestead Exemption in the amount of \$120.52 to Nazzie Wilson Ellis. Mr. Godsey seconded the motion. Upon roll call the following Council Members voted "Aye": Mr. Wheeldon, Ms. Dick, Ms. Lawson, Mr. Hunley, Mr. Minton, Mr. Godsey, Ms. Bullock and Mr. Dalton.
